RESOLUTION NO. 386 -2017

A RESOLUTION AUTHORIZING THE AWARD OF A BID FOR ELEVATOR IMPROVEMENTS AT TOWN HALL, DEPARTMENT OF PUBLIC WORKS AND MICHAEL J. TULLY PARK, DPW PROJECT NO. 17-05.

WHEREAS, the Town Clerk solicited bids for elevator improvements at Town Hall, Department of Public Works and Michael J. Tully Park, DPW Project No. 17-05 (the "Project"); and

WHEREAS, bids in response to the solicitation (the "Bids") were received and were opened, which Bids are as follows:

WHEREAS, after a review of the bids, the Commissioner has recommended that the contract for the Project be awarded to An Excelsior Elevator Corp., 640 Main Street, Westbury, New York 11590 (the "Contractor") as the lowest responsible bidder at its bid price of Four Hundred Six Thousand Two Hundred Seventy and 00/100 Dollars (\$406,270.00); and

WHEREAS, the Town Board desires to authorize the award of a contract to the Contractor as recommended by this Commissioner.

NOW, THEREFORE, BE IT

RESOLVED that a Contract for the Project is hereby awarded to the Contractor, as the lowest responsible bidder, at its bid price of Four Hundred Six Thousand Two Hundred Seventy and 00/100 Dollars (\$406,270.00), as more particularly set forth in an agreement which will be filed in the Office of the Town Clerk (the "Award"); and be it further

RESOLVED that the Award and any resulting agreement shall be subject to the approval of additional funding to complete all tasks relating to the Project; and be it further

RESOLVED that the Supervisor is hereby authorized to execute the contract documents, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney is hereby authorized and directed to supervise the execution of the contract documents to effectuate the Award; and be it further

RESOLVED that the Comptroller is hereby authorized and directed to pay the cost thereof upon receipt of duly executed contract and certified claims therefor.
